PERFORMERS CONTRACT

THIS AGREEMENT has been made and entered into on this \_\_\_\_\_ day of \_\_\_\_\_ (month) 2008 by and between the Zuni Fair Committee, and \_\_\_\_\_ hereinafter called the "Contractor".

NOW THEREFORE, in consideration of the premises and of the mutual and equal promises of the parties hereto.

IT IS HEREBY agreed by and between the parties that all performances and compensation during the 2008 Zuni Fair will be rendered under the following terms:

SCOPE OF SERVICE The Contractor will provide the following professional services to the Fair Committee.

*Perform traditional social dances during the evening performances/parades of the 2008 Zuni Fair.* \_\_\_\_\_

• COMPENSATION

For such services rendered satisfactorily as per this contract, the Fair Committee agrees to compensate the Contractor as follows:

\*\*Rates can be negotiated by Contractor and approved by the Fair Committee

\*\*All rates include compensation for banner holders.

**\*\*Performance time is limited to 10 minutes for evening performances.** \_\_\_\_\_.

Non-Zuni Royalty \$ 175.00

\*(Saturday Morning Parade & Saturday evening Performance. Must attend both scheduled events to receive full payment. )

Miss Zuni/Jr Miss Organization \$800.00 flat rate

(Must have a (1) one contract in place for organization)

Dance Groups \$800.00 flat rate

\*\*Two evening performances,(Friday & Saturday) One afternoon performances,(Sunday) three parades (Thursday-optional , Saturday & Sunday)

Dance Groups – Out of town: Rates remain the same as above.

(\*\*One vehicle can claim one way mileage to Zuni, ZMCFC will used per diem rates for the Zuni Tribe.)

Marching Band Group \$ 800.00 flat rate

(Friday, Saturday, Sunday parades and Grand Entry/Exit)

\*\*Must have a contract in place for payment

American Legion & Vietnam Veterans \$800.00 flat rate

(Friday, Saturday, Sunday parades and Grand Entry/Exit)

\*\*Must have a contract in place for payment

- It will be the group leader's responsibility to inform the ZMCFC appointed person during the line ups of who is absent. (Parade & Performances)
- Payment will only be given to the group leader. Partial payment maybe received on Saturday evening of \$400.00, after the night performance, the remaining amount will be paid out after ALL scheduled events on Sunday afternoon.
- It will be the group leaders responsibility to keep all dance group/marching participants at one location during night performances, this is one of the conditions which will void your bonus payment.
- Each group/marching will get a number to be identified for lineup and performances.
- An additional CASH bonus will be added to all contracts for dance groups, marching bands, etc.. on the conditions of the times indicated below. This will only be valid if you are on time on all the days and times indicated and as a whole group.

Thursday (8/28/08) for the parade 8:00 pm Parade at 8:30 pm

Friday (8/29/08) for evening performances 5:00 pm Performance @ 6:00 pm

Saturday (8/30/08) for the Morning parade 9:00 am (Tribal Building) Parade @ 10:00 am

Saturday (8/30/08) for the Evening performances 5:00 pm Performances @ 6:00 pm

Sunday (8/31/08) for the Morning parade 9:00 am (Tribal Building) Parade @ 10:00 am

Sunday (8/31/08) for Afternoon performances 12:30 pm Performances @ 1:00 pm

**All participants are invited to a FREE bar-b-que on Saturday at the Fair Grounds after the parade.**

Be ready and willing to fulfill this contract on the dates mentioned for evening performances as well as parades.

- COMPLIANCE

The Contractor shall observe all of the Zuni Fair's general rules and avoid any and all acts of moral turpitude, temperament, misconduct, or the consumption of alcoholic beverages or illegal substance, nor should the Contractor in any way hinder the successful operation of the Zuni Fair. The Fair Committee shall strictly enforce the Fair rules, and will be the sole judge of any violation of these rules, reserving the right to declare this contract null and void in the event of such violations. In such case, the Contractor will have no recourse against the Fair Committee for damages or nonfulfillment of this contract or for expenses incurred. \_\_\_\_\_

- CONTINGENCY

In the event that the Zuni Fair is not presented due to uncontrollable circumstances, this contract shall be in no force or effect whatsoever. \_\_\_\_\_

- WAIVER

In entering into this contract, the Contractor gives full and unconditional permission to be photographed/ video taped during performances at the 2008 Zuni Fair. \_\_\_\_\_
